The NCC is an independent Commonwealth Statutory agency that operates in accordance with Part IIA of the *Competition and Consumer Act 2010* (CCA) and this Annual Work Plan is determined in accordance with clauses 46 to 53 of the *Intergovernmental Agreement on National Competition Policy* (IGA).

Table 1 describes the functions of the NCC under the CCA, the IGA and the *Federation Funding Agreement – Affordable Housing, Community Services and Other – National Competition Policy Schedule* (FFA Schedule), and requirements for the 2026-27 Annual Work Plan. This Annual Work Plan covers the period from 1 July 2026 to 30 June 2027.
